- As per ASME Section IX Edition 2019 Now the Person who Certified the PQR shall have sufficient Knowledge based on experience Training and organization has to assign a person who is responsible for the WPS,PQR and WPQ.Also he had the sufficiednt knowledge of ASME Section IX ,organizational Quality Programme,scope complexity or nature special nature of activities to which oversignt is provided. Organization needs to be maintained the record of experiance, training and qualification.
- As per PED 2014/EU/68 all Quality records including radiographic film is to be maintained for 10 years after manufacturing of Product under PED requirements.
- >SNT-TC-1A Edition 2016 is now accepted by the ASME Section V Edition 2019 for Qualification and Certification of NDT Personnel.
